

UTAH GUN HUB — 2026 REFERRAL PROGRAM & GIVEAWAY

OFFICIAL RULES

**NO PURCHASE, PAYMENT, OR REFERRAL IS REQUIRED TO ENTER OR WIN.
VOID WHERE PROHIBITED OR RESTRICTED BY LAW.**

These Official Rules (“Rules”) govern the Utah Gun Hub 2026 Referral Program & Giveaway (“Giveaway”), sponsored by Utah Gun Hub (“Sponsor”). The Giveaway begins **January 1, 2026 at 12:00 AM MST** and ends **January 31, 2026 at 11:59 PM MST** (“Promotion Period”).

Throughout January, Utah Gun Hub will award **multiple prizes** through ongoing drawings and a final grand drawing.

1. ELIGIBILITY

The Giveaway is open only to individuals who:

- Are legal residents of the State of Utah;
- Are **21 years of age or older**;
- Have a valid UtahGunHub.com user account; and
- **Maintain an active SMS opt-in for Utah Gun Hub promotional messages during the entire Promotion Period and at the time of any drawing.**

Participation is optional. SMS opt-in is **not required** to use UtahGunHub.com, but **is required to enter or remain eligible for the Giveaway.**

Employees, owners, officers, and contractors of Utah Gun Hub and members of their immediate family or household, are not eligible.

Void where prohibited.

2. HOW TO ENTER — REQUIRED SMS OPT-IN

To enter the Giveaway, a user must:

1. Create or already have a Utah Gun Hub account; **and**
2. Check the Giveaway SMS consent box, which states:

“By checking this box, I confirm I am 21 years old or older and agree to receive promotional SMS messages from Utah Gun Hub, with this consent being optional and not required to use the website. Msg & data rates may apply. Unsubscribe anytime.”

This SMS consent must remain active throughout the Promotion Period.

If a user unsubscribes by replying **STOP**, disables messaging, or removes their phone number:

- **All entries become void,**
- **The user becomes ineligible,** and
- **Sponsor may select an alternate winner.**

No purchase, payment, or referral is required to receive the initial entry.

3. OPTIONAL BONUS ENTRIES VIA REFERRALS

Users with an active SMS opt-in may earn bonus entries.

During the Promotion Period:

- Each user receives a unique referral code.
- When a new user creates an account and enters that code, the referring user earns **one (1) bonus entry**.
- There is **no limit** to the number of bonus entries a participant may earn.

Referrals must be legitimate Utah residents with valid accounts.

Fraud, bots, fake phone numbers, or duplicate accounts will result in disqualification.

Bonus entries are **optional** and not required to win.

4. PROMOTION PERIOD

The Giveaway runs from **January 1, 2026 through January 31, 2026**.

All entries and referrals must occur within these dates.

5. PRIZES

Utah Gun Hub and participating sponsors will award **multiple prizes** throughout the Promotion Period.

Prizes may include:

- Firearms
- Firearm accessories
- Range items and memberships
- Gear and merchandise
- Gift cards
- Other sponsor-provided products

A complete list of prizes and approximate retail values (“ARV”) will be listed on the bottom of this document.

Sponsors may add additional prizes at any time.

Firearm Prizes — Legal Requirements

Certain prizes may include firearms provided and fulfilled by an independent, third-party federally licensed firearms dealer (“FFL Sponsor”). Utah Gun Hub does not manufacture, sell, store, transfer, or deliver firearms.

If a prize includes a firearm:

- The firearm prize is **sponsored, awarded, and transferred solely by the FFL Sponsor**, and is subject to all policies, procedures, and requirements established by that FFL Sponsor.
- Winner must be **legally eligible** to possess a firearm under all applicable federal, state, and local laws.
- All firearm transfers must be completed **in person** through the FFL Sponsor or another licensed dealer designated by them.
- Winner must complete **ATF Form 4473** and successfully pass all required background checks.
- The FFL Sponsor retains **full and sole discretion** to:

- Approve or deny any firearm transfer;
 - Require additional documentation or verification;
 - Substitute a firearm of equal or lesser value;
 - Impose waiting periods, transfer fees, storage limits, or other conditions; and
 - Decline to complete the transfer if legal, regulatory, or internal policy requirements are not satisfied.
- If a winner fails a background check, is deemed ineligible, or does not complete the transfer within the timeframe specified by the FFL Sponsor, the firearm prize is **forfeited**, with no cash substitution or replacement.
 - Utah Gun Hub has **no authority or involvement** in firearm eligibility determinations, transfer approvals, or firearm substitutions.

By participating, entrants acknowledge that **firearm prizes are governed exclusively by the FFL Sponsor's rules and applicable law**, not by Utah Gun Hub.

6. WINNER SELECTION — MULTIPLE DRAWINGS

Utah Gun Hub will conduct **Ongoing prize drawings** during the Promotion Period;

To remain eligible for any drawing, a user must:

- Maintain an active account; and
- **Maintain active SMS promotional consent at the time of the drawing.**

Odds of winning depend on:

- Total number of eligible entries,
- Number of bonus entries earned, and
- Number of prizes offered.

Sponsor's decisions are final and binding.

7. WINNER NOTIFICATION

Winners will be notified via:

- **SMS**, and/or
- Phonecall
- Email (if provided).

Winners must respond within **72 hours**.

Failure to respond, failure to meet eligibility requirements, or unsubscribing from SMS prior to notification will result in disqualification, and an alternate winner may be selected.

8. GENERAL CONDITIONS

By participating, entrants agree to:

- Comply with all Rules;
- Maintain active SMS opt-in status;
- Not engage in fraud, system manipulation, or referral abuse;
- Permit Sponsor to disqualify any entrant for misconduct.

Sponsor may modify, suspend, or cancel the Giveaway if technical, fraud, or security issues arise.

Participation is voluntary. Messaging frequency varies. Standard message and data rates may apply.

9. PUBLICITY RELEASE

Where permitted by law, winners grant Sponsor and Utah Gun Hub the right to use their:

- First name,
- Last initial,
- City of residence, and
- Likeness

for promotional purposes without compensation.

10. LIMITATION OF LIABILITY

Sponsor and prize providers are not responsible for:

- SMS delivery failures;

- Technical issues, outages, or delays;
- Lost, damaged, or misdirected communications;
- Failed background checks;
- Injuries or damages related to participation or prize use.

Liability for any prize is limited to its ARV.

11. DISPUTE RESOLUTION

All disputes shall be resolved individually by binding arbitration in **Salt Lake County, Utah**.
Utah law governs all aspects of the Giveaway.

12. SPONSORS

Prizes are provided by participating firearms businesses and partners.
